Nature Of Contested Conservatorships

- Objection by the proposed conservatee
- Objection by a family member, including a spouse
- Competing petition for appointment of a conservator









- Desire for control by proposed conservatee –
 " I am handling things just fine. I don't need
 any help"
- Disputed changes to an estate plan
- Desire for control by other family members typically a dispute among siblings or proposed conservatee's spouse




Does It Matter Who Contests

Proposed Conservatee

If contested by the proposed conservatee important to respect their wishes if possible and to comply with the applicable provisions of the Probate Code


Who Will Serve?

Different scenario if need for conservatorship is not disputed but issue is who will serve





Process When A Conservatorship Is Contested




Court-appointed counsel or Guadian ad Litem?

Need for temporary conservatorship of person or estate to address immediate issues? Neuropsychological evaluation?

Formal discovery: depositions, subpoena of medical and/or financial records, Requests for Production of Documents Right to a jury trial if requested by the proposed conservatee





Significance Of Trust, Power Of Attorney For Asset Manangement Or Health Care Directive

- Simultaneous trust petition seeking to remove/replace trustee and accounting?
- Revocation of powers of attorney
- Focus on orderly management of assets



Red Flags Of Abuse, Neglect And Undue Influence

Change of circumstances regarding living arrangements

- New "friend" or spouse moving into the residence
- Isolation by family members or caregiver "they don't want to speak with or see you" or "they are sleeping"
- Residence not properly maintained despite caregiving arrangements
- People living in the residence but not paying rent or providing services
- Change of residence of proposed conservatee without notice

Change in Finances

- Unusual use of credit cards/ATM withdrawals
- · Bills not being paid, e.g. utilities turned off
- · Gifts or "loans" made to friends or family

Change in Medical Condition

- Failure to seek care from health care professionals
- · Failure to take medication as prescribed
- Frequent falls residence not properly equipped for safety




Role Of Court Investigator Report

- 1. Critical piece of information for consideration by the parties
- 2. May include answers to questions regarding motivation for seeking changes to an estate plan, new friendships, termination of relationships, etc.
 - Some questions we wish the estate planner had asked.
- 3. May include suggestions for alternatives to conservatorship




Role Of Mediation
